

Keri Keri Wind Farm



Location: 35km east of Balranald and 30km from Moulamein in south west New South Wales

Capacity: Up to 884MW, with potential 200MW/800MWh battery storage

Structure: Wind turbine and battery storage, with up to 155 wind turbines on site

Jobs: Peak workforce of approximately 650 during the wind farm construction phase and up to 30 full-time roles once the wind farm becomes operational

Construction commencement: 2027

ABOUT THE PROJECT

The Keri Keri Wind Farm is a proposed renewable energy project, located in south west New South Wales. The current project boundary encompasses more than 18,000 ha of land. The area is characterised by large pastoral holdings predominantly used for merino sheep farming. The structure will be formed of wind turbines and a battery energy storage system (BESS), with up to 155 turbines on site.

The site is exposed to consistent winds and is located within the proposed South-West Renewable Energy Zone, which is one of five areas identified by the New South Wales Government as a priority region for the development of renewable energy projects.

CONNECTION TO COUNTRY

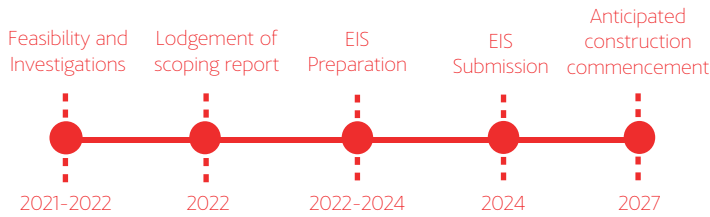

LOCATION OVERVIEW

The proposed Keri Keri Wind Farm would be located approximately 35kms east of Balranald and 30kms from Moulamein in south west New South Wales. The site is located east of the Yanga State Conservation Area and the Murrumbidgee Valley, within the Murray River local government area. The site is flat and has good access to transport infrastructure via the Sturt Highway and other local roads.



ANTICIPATED TIMELINE



The proposed Keri Keri Wind Farm is considered a State Significant Development under the Environmental Planning and Assessment Act 1979.

ACCIONA Energía lodged Scoping Reports and Secretary's Environmental Assessment Requirements (SEARs) from the NSW Government during 2022 and have lodged the Environmental Impact Statement (EIS), as of 2024, with an anticipated construction commencement of 2027.

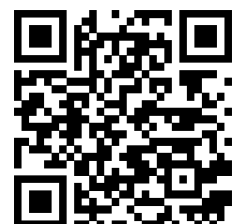
